Treasurer's Report:

Director Turner presented the Treasurer's Report which was duly received and filed.

Board Action on Agenda Items:

1. Silverado Place Emergency Work:

The work has been completed in a satisfactory manner and payment of associated invoice approved.

2. Annual Road Evaluations:

This item was tabled until the next Board meeting in February because a substantial amount of rain is forecast for the coming weeks which might change the current

condition of the roads. If it becomes necessary in the interim to do any emergency repair work, it can be approved by Board members via either an e-mail or telephone vote. President Fulmer will add a message to the District web page asking residents to keep culverts clean of debris. Director Turner made a motion, seconded by Director Bradley, to approve the purchase of 2 street name signs for Buck Way and the hardware to install them... Motion passed. Director Bradley will purchase the signs which will be installed at the intersections of Forked Horn and Buck Way and Blacktail and Buck Way.

3. Permit Status Report:

There were no inspections made during the month of December. The report was received and filed.

4. Culvert Mapping:

Director Turner presented the Board with copies of the map which shows the location of all existing culverts in the District. In addition to showing the location of culverts, the condition of each is also given. The report will be complete after the addition of information collected by resident Peggy Williams on various roads which she has surveyed.

5. Wallace Group Rate Increase:

.A motion was made by Director Turner and seconded by Director Simons to approve a 2.5% increase in rates by the Wallace Group per the Consulting Services Agreement... The motion passed four to one in favor.

6. Blacktail Place

Manager Lepore presented the staff report on meetings with County staff. County staff admitted there had been oversights on their part in the inspection process but that it is too late now to do anything about these oversights. The Board discussed what options they have for the future including having the County oversee all new construction or having the CSD do their own analysis, plan check and inspection. Wallace Group staff will continue to report back to the Board on future discussions with the County staff.

7. Contract Form:

The Board will continue to look into hiring an independent contract inspector. Staff will try to determine if said contractor can be a resident of the District. A job description along with pay rate will need to be determined. Staff was directed to research and prepare a draft job description to be reviewed by the Board. Once the Board has approved the job description, and legal counsel has given the green light, President Fulmer will contact Chris Gimenez to add a notice to the District's web page looking for interested parties to fill the position.

8. Proposed Easement to GSHCSD for property at Geneseo and GSH:

This issue is being researched by President Fulmer who is contact with LAFCO and District Counsel. At the present, it has been determined because the area in question is not within District boundaries The Board has no jurisdiction over this area and does not want to incur any expenses associated with its repair.

9. Resolution No.2010-01 Recognizing District Services of Kit Carter:
