MINUTES FOR SEPTEMBER 12, 2012 BOARD MEETING

Call to Order and Flag Salute:

Director Fulmer called the regular meeting to order at 7:00 p.m.

Roll Call:

Directors Fulmer, Simons, Turner, Milbury and Bradley were in attendance. Manager Lepore, and Secretary Giminez were also present.

Closed session reportable action; The reportable action to accept John D'Ornellas' proposal for GM contract position dated August 2nd, 2012 and direct Staff to coordinate legal service contract with District legal counsel.

Director Simons made a motion to accept and approve the August Regular Meeting Minutes, the Treasurer's Report, payment of the outstanding invoices and Manager Lepore's report. Director Turner reported that the San Luis Obispo Auditor Controller debited the Districts tax account by \$271.34 in August. The SLO County Auditor's office explained that the District is paid unless a default on a property tax payment occurs than that amount would be deducted until the property owner pays the taxes owed.

Director Fulmer reported that she received two complaints on recent road work.

Public Comments on Agenda:

Ms. Sue Williams reported that some progress has been made on the Forked Horn Project. She has filed with the State of California Mutual Benefit Corporation. As of last week she has also filed with the Franchise Tax Board for exemption. Following the approval of these items a bank account will be opened. Bylaws have been drafted but may go through some revisions as they proceed. Bylaws will be distributed to the property owners of Forked Horn when completed. Ms. Williams welcomed any board input.

Board Action on Agenda Items:

1. Permit Status Report

There are currently nine (9) active permits, five (5) permits on hold and sixty three (63) final permits. Two permits were finaled during the month of August.

2. Annual Road Evaluations

On August 14, 2012, Director Simons and Manager Lepore drove the roadways recently repaired by Viborg Sand and Gravel and documented the condition of the repairs two weeks after project completion. It was noted that there were areas of wash boarding and potholing already occurring. When Viborg was contacted regarding the Districts concerns, Staff was informed that the contractor has completed the work as contracted and no further repairs will be made at this time.

After Board discussion of the work performed by Viborg, it was concluded that future bids from this company may not be considered because of poor workmanship on several contracted jobs.

Director Turner suggested that we wait until after the first rains before contracting road repairs, the wet roads may rectify some of the compaction problems.

Public Comment

Mr. Bayus informed the Board that his company could deliver a load of base for \$400, which cost less than the last delivery.

It was also reported that the culvert at the end of White Tail (5025) is crushed. Director Simons will inspect the culvert and report back at the next regular meeting.

3. District Website

At the August regular meeting, the Board directed staff to coordinate updates to the District Website. The Board also requested a proposal for on-going maintenance and hosting. Staff has contacted Chris Giminez with Cyber-Scriber regarding the proposed edits.

The District's website has been a beneficial tool for residents within the community. Staff has reviewed the existing website in detail and has made some suggestions for updates. Estimates for this work are listed below.
