WHEREAS, the Ground Squirrel Hollow Community Services District (“District”) became effective July 29, 2004, pursuant to an election and Resolution of the Board of Supervisors of the County of San Luis Obispo, and under the authority of the Cortese-Knox-Hertzberg Local Reorganization Act of 2000 (Government Code § 56000 et seq.); and

WHEREAS, the Ground Squirrel Hollow Community Services District (“District”) was formed in 2004 pursuant to Sections 61000 et seq. of the Government Code (“GC”) commonly known as the Community Services District Law; and

WHEREAS, the District is currently authorized to acquire, construct, improve, and maintain streets, roads and right of ways, bridges, culverts, drains, curbs, gutter, sidewalks and any incidental work pursuant to GC§61100(L);

A district shall not acquire, construct, improve, or maintain any work owned by another public agency unless that other public agency gives its written consent.

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE GROUND SQUIRREL HOLLOW COMMUNITY SERVICES DISTRICT TO INITIATE 2012-2013 SPECIAL TAX FOR STREET IMPROVEMENTS WITHIN THE DISTRICT

WHEREAS, the Ground Squirrel Hollow Community Services District (“District”) became effective July 29, 2004, pursuant to an election and Resolution of the Board of Supervisors of the County of San Luis Obispo, and under the authority of the Cortese-Knox-Hertzberg Local Reorganization Act of 2000 (Government Code § 56000 et seq.); and

WHEREAS, by said Resolution and the resulting election, the Ground Squirrel Hollow Community Services District, pursuant to Government Code §61600(j) and (k) is authorized to exercise the following services:

- (j) The constructing, opening, widening, extending, straightening, surfacing, and maintaining, in whole or in part, of any street in the District, subject to the consent of the governing body of the county or city in which the improvement is to be made; and
- (k) The construction and improvement of bridges, culverts, curbs, gutters, drains, and works incidental to the purposes specified in subdivision (j) subject to the consent of the governing body of the county or city in which the improvement is to be made; and

WHEREAS, the residents within the District voted to establish a special tax as part of the above election to finance the services more particularly described in the above Recitals at the rate of two hundred forty dollars (\$240) per parcel to increase no more than two percent (2%) annually, unless otherwise approved by the electorate, as provided by state law.

NOW THEREFORE, BE IT RESOLVED THAT THE BOARD OF DIRECTORS OF THE GROUND SQUIRREL HOLLOW COMMUNITY SERVICES DISTRICT, COUNTY OF SAN LUIS OBISPO, STATE OF CALIFORNIA, HAVING DULY CONSIDERED THE SAME, DO HEREBY DECLARE AND ADOPT THE FOLLOWING:
